**UNDERTAKING FOR SUBMISSION OF POST-DATED CHEQUES (PDCs)

2. Submission of Post-Dated Cheques (PDCs)

That we shall submit, along with the tuition fee and hostel fee for the current academic year (2025), duly signed post-dated cheques (PDCs) covering the fee for each subsequent academic year, as under:

- Three (03) PDCs of ₹15,50,000/- each, towards Tuition Fee for the academic years 2026, 2027, 2028, and One (01) PDC of ₹7,75,000/- for the academic year 2029.
- Four (04) PDCs of ₹3,15,000/- each, towards Hostel Fee for the academic years 2026, 2027, 2028, and 2029.

3. Intimation before Presentation of PDCs

That the College administration shall, as a matter of good practice, send a prior intimation by SMS/email/official notice before presenting the said PDCs for clearance with the concerned bank.

4. Responsibility in Case of Dishonour

That in the event of dishonour of any such post-dated cheque(s), the entire responsibility, liability, and consequences – civil, criminal, financial, and disciplinary – shall rest solely upon us (parents/guardians and the student). The College shall have full right to take appropriate legal action under the Negotiable Instruments Act, 1881 and any other applicable laws, in addition to instituting administrative action.

5. Continuity of Obligation

That this undertaking shall remain valid and binding upon us throughout the entire duration of the MBBS course (2025–2029), irrespective of change in circumstances, withdrawal, or discontinuation of the course by the student.

6. Indemnity

That we hereby indemnify and keep indemnified the College against any loss, damage, or proceedings that may arise due to dishonour, non-payment, or delay in payment of such tuition and hostel fees covered by PDCs.
